Sub: Constitution of Group of Minister (GoM) for Micro, Small and Medium Enterprises (MSME)-reg.

In pursuance of decision in the 29th Meeting of GST Council held on 4th August 2018 at New Delhi, a Group of Ministers (GoM) for MSME has been constituted. The **GoM for MSME** shall consist of the following members:

2. The Terms of reference (ToR) for the GoM for MSME shall be as follows:
 - a. Identify the measures to be taken after examining the recommendations of the Law Committee, the Fitment Committee and the IT Committee on the representations and suggestions relating to MSME received from stakeholders prior to 29th meeting of GST Council held on 04.08.2018, or as deliberated in the said Council meeting, or new suggestions and representations received subsequently including for procedural changes;
 - b. Identify any other measures to be taken to provide conducive environment for the growth of MSME;
 - c. Estimate and project revenue impact of their recommendations, wherever relevant.
4. The GoM for MSME will be assisted in its work by Shri Manish Kumar Sinha, Joint Secretary, TRU-II.
5. The Finance Minister of any other State, if desirous, may join any meeting of GOM on MSME.



6. The GoM may invite any other officer(s) for the meetings, as required, including from other departments.
7. The Law Committee, Fitment Committee and the IT Committee will examine the suggestions pertaining to them and submit their recommendations to the GoM.
8. The GoM for MSME shall submit its final report to the GST Council within two months. During the interregnum, it may submit interim report(s) for consideration of the GST Council. It may also take decision on minor issues brought before it by the three Committees and place such decisions before the GST Council.
9. This issues with the approval of the Hon'ble Union Finance Minister and Chairperson, GST Council.
