The Committee will examine and resolve all the grievances and issues being faced by the taxpayers including procedural difficulties and IT related issues pertaining to GST, both of specific and general in nature. It will also refer any issue requiring a change in Act/Rules/Notification/Form/Circular/ Instruction, etc. to the GST Council Secretariat and the respective Policy Wing of the CBIC.

The Committee will meet once in every quarter or more frequently as decided by the co-chairs.

The officers mentioned against serial no. VII in the above table will act as Secretaries of the GRC. The stakeholders may send their grievances/suggestions to the Secretaries of the Committee, who will place the same before the Committee. The Secretary of the Committee shall also submit a quarterly progress report to the GST council Secretariat as well as to the GST Policy Wing, CBIC.

The previous order bearing no. 207/2022 dated 29.11.2022 in this regard, stands cancelled.
