Minutes of the Co-ordination Meeting between CGST and SGST Officers held on 24th March 2025 at the office chamber of Commissioner, CGST Dimapur.

A Co-ordination Meeting between CGST and SGST Officers, comprising of CGST officers led by Shri RH Meena, Commissioner of CGST Dimapur and SGST officers led by Shri Abhinav Shivam, Commissioner of State Taxes department, Nagaland, was held on 24th March, 2025, at 11:30 hrs, at the office chamber of the Commissioner, CGST Dimapur. The Commissioner, CGST Dimapur welcomed the gathering and the following points were discussed: -

Discussion Points & Resolutions:

1. Periodic Joint Operations:

It was resolved to conduct periodic joint operations in border areas, highways, railways, far-flung coal-belt areas, and veneer/ply factories to verify GST compliance in transit documents. If required, police protection may be sought for these operations.

2. Designation of Contact Point Nodal Officers:

To ensure smooth and effective coordination at the field level, the following officers were designated as contact point nodal officers:

- **Shri Dr.Thejaselhou Yhome** - Deputy Commissioner (Anti-Evasion), CGST Dimapur, Mobile No: 8974713565.
- **Smt L Yanbeni Humtsoe** - Assistant Commissioner (Mobile squad), State Taxes Department, Nagaland, Mobile: 9402809264.

3. **Sharing of Database and Investigation Reports:**

It was agreed to share a database of fake firms and exchange detailed investigation reports on major cases from time to time.

4. **Installation of Check Post at Railway Premises:**

A decision was made to jointly request the railway authorities for space to set up a check post at the Dimapur railway station premises, as per Para-9 of **FM Circular No. 07/2024 dated 23.02.2024**.

5. **Introduction of Reward System for SGST Officers:**

The Commissioner, State Taxes Department, Nagaland expressed interest in introducing a reward system for deserving officers, similar to the existing framework in CBIC followed by the CGST officers.

6. **Request to State Tax authority to shift GST administration of one taxpayer from State to Centre jurisdiction in view of the Budgetary Support Scheme for M/s Greenply Industries Ltd:**

Budgetary Support Scheme is a Centre administered scheme wherein 58% of CGST amount paid by cash and 29 % of IGST paid by cash is re-imbursed to the manufacturer by the Central government to boost up manufacturing activity in special states like Nagaland. For effective monitoring, this party was requested to be switched from State to Centre administration, if approved by state authority.

The meeting concluded with a commitment to strengthen coordination and enforcement efforts between CGST Dimapur and the State Taxes Department, Nagaland.
