No. TAX/4(53)/GST-NOTN/2016:- In exercise of the powers conferred by sub-sections (1) of section 11 of the Manipur Goods and Services Tax Act, 2017 (3 of 2017), the State Government, on the recommendations of the Council, hereby makes the following further amendments in the notification of the Government of Manipur, Secretariat: Finance Department (Expenditure Section), No. 2/2017-StateTax (Rate), dated the 28th June, 2017, published in the Gazette of Manipur, Extraordinary, vide number 111, dated the 29th June, 2017namely:-

In the said notification, -

- 1. In the schedule,
 - i) for S. No. 43A and the entries relating thereto, the following serial numbers and the entries shall be substituted, namely:-

"43.A.	5/10	Vegetables (uncooked or cooked by steaming or boiling in water), frozen
43B	0711	Vegetables provisionally preserved (for example, by sulphur dioxide gas, in brine, in sulphur water or in other preservative solutions), but unsuitable in that state for immediate consumption";

ii) after S. No. 121 and the entries relating thereto, the following serial number and the entries shall be inserted, namely: -

iii) after S. No. 152 and the entries relating thereto, the following serial number and the entries shall be inserted, namely: -

"153	Any	Supply of gift items received by the President, Prime Minister,
	charter	Governor or Chief Minister of any State/ Union Territory, or any
1	Í	public servant, by way of public auction by the government, where
		auction proceeds are used for public or chantable cause".

2. This notification shall come into force on the 1st January, 2019
