Notification No.19/2017-State Tax (Rate)

Maharashtra Goods And Services Tax Act, 2017.

No. MGST-1017/C.R.139/Taxation-1.—In exercise of the powers conferred by sub-section (1) of Section 9 of the Maharashtra Goods and Services Tax Act, 2017 (Mah. XLIII of 2017), (hereinafter referred to as "said Act"), the Government of Maharashtra, on the recommendations of the Council, hereby makes the following further amendment in the notification of the Government notification of the Finance Department No. MGST 1017/C.R. 104/Taxation-1, [No. 1/2017-State Tax (Rate)], dated the 29th June, 2017 published in the Maharashtra Government Gazette, Part IV-B Extraordinary No. 183, dated the 29th June, 2017, namely:—
